

## An Invitation to Local Artists

The Park Club of Kalamazoo is hosting its  
The Fifth Annual Juried Art Exhibit, Friday, October 22, 2010.

### There have been several changes made for 2010.

There will be an entrance fee of \$10.00 for 2010. This fee is to offset the expense of mailings and additional administrative time and may be paid by check or cash to the Park Club when registering for the Exhibit. Also new for 2010 is a 10% commission paid to the Park Club on all artwork sold.

The invitation to participate is extended to all local artists. The theme for this year is “All Things Michigan”.

The Park Club will accept artwork of all mediums, from persons of all ages and abilities. This year's prize packages will include items such as gift certificates for dining at the Park Club, and local vendors and establishments.

Entries will be accepted on October 12th and 13th, between 2-4pm in the Reading Room at the Park Club or by appointment. A registration form is attached to this email, however additional forms and information can be found on the Park Club website at [www.parkclub.net](http://www.parkclub.net).

Winners will be announced at the Opening Reception at the Park Club's 4th Friday Event on Friday October 22, 6-8pm where all works will be on display for Park Club members and their guests, and participating artists and their guests. Prizes will be awarded at 7pm. There will be appetizers served and drinks coins may be purchased at the Lobby desk along with check in for artists and guests.

The opening will **NOT** be open to the public so artists will be required to provide guest names to the Park Club and artists and guests will check in at the lobby desk. Artists will receive a nametag when he/she checks in. Each finalist will receive **two tickets** to the event and will be allowed to purchase additional tickets, if desired (on a first come, first served basis) at \$5. each. Please contact the Park Club by Wednesday, October 20 with guest names and to reserve additional tickets. Tickets may be paid for at the lobby desk.

## “All Things Michigan”

The fifth annual juried art exhibit at the Park Club will open Friday, October 22, 2010 and will run through November 30, 2010. The opening reception is October 22, 2010 6-8pm with Prizes awarded at 7pm. There will be appetizers served and drinks coins may be purchased at the Lobby desk along with check in for artists and guests.

The theme this year is “All Things Michigan” and is open to all artists.

Space is limited to forty exhibitors. Entrants will be juried for the forty slots and a final jury will pick the winning entry.

### Entries will be accepted in the following categories:

**Two – Dimensional** - including:

Oil and acrylic painting, pastels, watercolor, mixed media, silkscreen, photography – all formats, computer generated art and all 2-D entries must be suitably framed

**Three – Dimensional** - including:

Ceramics, Fabric, Jewelry, Paper (may also qualify for 2-D), Collage

Sculpture – including: metals, wood, stone, clay, mixed media and found objects

Video entries will not be accepted due to exhibit limitations.

Entries may be decorative or functional but must be in keeping and representative of the theme “All Things Michigan”. There is a size restriction on two-dimensional art. The diagonal of the piece may not exceed 48 inches or if larger must be approved by the Park Club Art Committee. Three-dimensional art is limited to 36 square inches at the base and height is not an issue.

All art may be for sale or NFS, (Price on Request are no allowed) and the Park Club will receive a 10% commission.

Buyers pay artists directly. Artist pays Park Club 10% commission.

There will be prizes awarded to the winning top three entries.

## Terms and Conditions:

**Entries:** By submitting entries, the artist accepts the terms of this event and agrees to be bound by its rules. The Park Club retains the right to make final determinations regarding any aspect of this show. Participants under 18 years must have a parent or guardian sign an acknowledgement of these rules.

**Work Eligible:** Only original work completed during 2010 may be entered. Works may be in any medium, such as painting/drawing/print-making/photography/sculpture. The theme this year is “All Things Michigan”.

**Delivery of Entries:** Entries must be hand-delivered to:

**The Park Club**, 219 West South Street, Kalamazoo, Michigan

either Tuesday October 12, or Wednesday October 13, 2010 - between 2-4pm or by appointment.

**Notification:** Notification of acceptance status for each entry will be mailed on or about October 14, 2010. Those entries designated as finalists will be eligible for recognition and award prizes.

**Please be sure to self-address the “Results of the Jury” card at time of registration.**

**Condition of Entry:** All works must be framed for hanging and should have proper hanging devices and wires attached. **Please indicate, “top” where necessary.** No clip frames will be allowed. The Park Club reserves the right to refuse any entry and to withdraw any work from the exhibition at its discretion.

**Liability:** All work is submitted at the owner’s risk. Although every precaution will be taken, The Park Club is not responsible for insurance of work during transit or while on its premises. By submitting work, the artist waives any claim against The Park Club for any loss or damage.

**Sale of Works:** Accepted entries may be eligible for sale, however if a work is not for sale, please indicate NFS on the entry card. No PORs (Price on Request) will be accepted. Prices must be listed. Works offered for sale will be sold as exhibited; no substitutions or other copies of the same work will be permitted. The Park Club will receive a 10% commission on all artwork sold.

**Reception and showing:** The Park Club will host a reception for members and guests, and exhibiting artists (finalists) and their guests, on Friday October 22, 2010 from 6-8pm.

**Judging and Prizes:** Entries designated as finalists will be reviewed by a panel of judges consisting of members of The Park Club and the Kalamazoo art community. The Park Club will award one grand prize from all chosen finalists, as well as first and second place prizes. Honorable mentions will also be recognized.

**Prizes Packages** will include gift certificates for local vendors and establishments and dining at the Park Club.

**Prizes will be awarded as follows:**

• **Grand Prize Package:** Best overall work. • **First place** • **Second place** • **Honorable Mention**
